QUALIFYING ENHANCED PARTNERSHIP SERVICE DECLARATION SUPPLEMENTARY APPLICATION FORM TO REGISTER A NEW BUS SERVICE OR CHANGE AN EXISTING SERVICE

This form identifies whether the service(s) you are registering need to adhere to the requirements set out in the Enhanced Partnership Scheme and are therefore Qualifying Enhanced Partnership Services. Bus operators are required to declare through this form that any qualifying service(s) being registered meet the requirements set out in the Enhanced Partnership Scheme.

The form is to be submitted with registration documents for a new bus service or variation of an existing service that travels wholly within or is cross-boundary into the West of England Enhanced Partnership area. The West of England Enhanced Partnership area covers the local authority areas of Bath and North East Somerset, Bristol, North Somerset and South Gloucestershire. **This form is not required if you are registering to cancel a service.**

The Enhanced Partnership Plan details the overarching bus service improvement objectives for the Enhanced Partnership area. The Enhanced Partnership Scheme details the agreed obligations on bus operators, the Local Transport Authorities and Local Highways Authorities. Both documents are subject to periodic review through the Enhanced Partnership governance process, detailed in Section 4 of the Enhanced Partnership Scheme. For services that operate wholly in the West of England Enhanced Partnership area, the West of England Mayoral Combined Authority acts as the Bus Service Registration Authority for registration applications.

For all services that operate across boundaries between the West of England Enhanced Partnership area and neighbouring areas, the Traffic Commissioner remains the registration authority. If you are registering a service that is cross-boundary into, the West of England Enhanced Partnership area, please complete this form, and submit alongside the relevant Traffic Commissioner forms, in the first instance, to bus.registrations@westofengland-ca.gov.uk for approval. On approval and receipt of a proforma from the West of England Mayoral Combined Authority and/or North Somerset Council, this form should be included in your subsequent submission to the Traffic Commissioner.
